- v. List of equipment including lay-out sketch of the antenna.
- vi. Proof of 1 year PARS membership as Short Wave Listener (SWL) for age 18 years & above and 2 years SWL for age 12 years and below 18 years.
- vii. Sketch of the exact geographical location so that the station is easily approachable by the PTA Inspector for inspection/verification.
- viii. Any other certificate/testimonial which can support the case for grant of Amateur License.
