1.	<p>Could PTA help to offer the document consisting the following information :</p> <p>i) Tender guarantee is acceptable for the foreign consultants (considering the different policies adopted by the foreign banks, in some countries, bank can not issue the performance guarantee before signing of the contract)</p> <p>ii) Reflection of project budget (considering the different policies adopted by the foreign banks, in some countries, bank guarantee cannot be issued without the contract price)</p> <p>iii) Conditions for the return of bank guarantee (if fail in the bid)</p>	<p>i) There is no requirement of furnishing Tender Guarantee along with proposal. Non-refundable processing fee of USD 500 or Pak Rs 86,500 is payable with proposal. Further, only successful bidder shall be required to furnish Performance Bank Guarantee (PBG) and Corporate Guarantee (CG) before signing of the contract. PBG and CG shall be released after successful completion of the assignment.
