3. Bids must be accompanied by earnest money equivalent to 2% of bid price
4. Bids shall be submitted to the office of undersigned upto **06 May 2015**, by **11:00 AM**. Only Technical Proposal will be opened on the same date i.e. **06 May 2015** at **11:30 AM**.
5. PTA reserves the right to accept/reject any/all bids without assigning any reason as per PPRA Rules.

Terms & Conditions

1. Tender Notice issued in the PPRA/PTA Websites is part of Bidding Document.
2. Tender should be addressed to the Deputy Director, Pakistan Telecommunication Authority, Plot # 11, Sector A-3, Phase-5, Hayatabad, Peshawar.
3. **Mandatory requirements:**
 - i. **Registration with Income tax and Sales tax departments (copies to be attached).**
 - ii. **Fulfillment the minimum technical specifications mentioned at Annex-5.**
4. The supply of desktop Computers with LED will be according to PPRA Single stage – two envelope procedures.
5. Bid shall be submitted in a single package containing two separate envelopes clearly marked as “TECHNICAL Proposal” and “FINANCIAL Proposal”.
6. Initially, only the envelope marked “TECHNICAL Proposal” shall be opened.
7. The envelope marked as “FINANCIAL Proposal” shall be retained in the custody of the PTA without being opened.
8. PTA shall evaluate the technical proposal in a manner prescribed in advance, without reference to the price and reject any proposal which does not conform to the specified requirements. Evaluation of Technical Proposals will be made for only those bidders who fulfill the mandatory requirements.
9. During the technical evaluation no amendments in the technical proposal shall be permitted.
10. Financial bids of only technically qualified bidders shall be opened.
11. The bidder should quote rates clearly in the financial bid. Cutting & over writing will not be accepted and bid will be rejected.
12. The computers should be new, not used or refurbished.

13. The equipment should be arranged through the legal channels by providing all duties/taxes (if any) levied by the Govt. and towards this end.
14. Vendor will be responsible for the provision of free at least one year warranty/ support with parts.
15. The warranty period will be considered from the date of actual date of delivery of computers.
16. Vendor will be responsible for the safe supply of computers at PTA Zonal Office Peshawar.
17. Delivery of items to be made within six weeks after issuance of supply order.
18. 01% of the total value of supply order will be charged as penalty (Per week) on late supply of computers up to a maximum of six weeks. (Days less than six will be considered as one week). After expiry of six weeks, supply order shall stand cancelled and earnest money will be forfeited.
19. Weight age of Technical and Financial proposals will be 70% and 30% respectively.
20. The bidder obtaining highest marks combining both Technical and financial proposals will be awarded the contract.
21. If two or more bidders obtain equal marks in aggregate, then the contract will be awarded to the one with lowest financial bid.
22. Evaluation criteria are given in the technical proposal. Minimum threshold for qualifying in the technical proposal is 70. Financial bids of only technically qualified bidders shall be opened.
23. Evaluation criteria of financial proposal are as under.

Financial Score=

$$30 \times \frac{\text{Amount quoted by lowest company in financial bid}}{\text{Amount quoted by the company whose financial score is to be calculated}}$$

24. Earnest money equal to 2% of total bid price (Refundable to the unsuccessful bidders) in shape of pay order / Bank draft in favor of Pakistan Telecommunication Authority, should be attached with the financial bid (Cheque will not be accepted). A certificate regarding submission of 2% earnest money along with financial bid shall be attached with technical bid. Bid without earnest money will be rejected forthwith.
 25. Earnest Money of un-successful bidder will be returned on issuing of contract to successful bidder.
 26. Retention money is limited to 6% of the total bid price. 2% Earnest money of successful bidder will be converted into retention money and remaining 4% will be deducted from invoice. Retention money will be released within 2 months of completion of warranty period.
 27. Bid validity period will be 90 days.
 28. Bid shall be submitted inclusive of GST.
 29. Taxes and duties will be deducted as per Government rules.
 30. GST&NTN registration date must be before of tendering date
 31. Interested sole distributor / authorized supplier may forward their proposals as per above instructions to the undersigned latest by 6th May 2015 at 11:00 am.
 32. All pages of Technical and Financial Proposal will be **signed and stamped** with by the bidder.
 33. Pakistan Telecommunication Authority, Zonal Office Peshawar reserves the right to accept or reject any or all bides as per PPRA Rules.
