SPECIAL STIPULATIONS

Supply & Fixing of Security Equipment for PTA Zonal Office, Lahore

The stipulations outlined hereunder in the form of a table summarize certain terms & conditions and these stipulations will be an integral part of the contract:

1	Tender will be evaluated on the lump sum basis as a whole price of the project, whereas, the pricing and evaluation will be considered on the item rates. Final Payment will also be made by measuring actual quantities on itemized basis.	
2	No claim on Escalation during the currency of Contract will be entertained	
3	Arbitration	In case of any dispute or conflict between Contractor and Employer, the case will be referred to Purchase Committee-I, PTA.
4	In case of increase in quantities more than 15%, the prior approval of competent authority of Employer must be obtained otherwise no claim will be entertained on excess quantities	
5	Employer has full right to execute any portion of work or whole work or cancel the execution of whole work and full right to increase or decrease the quantum of work or quantities.	
6	Amount of Earnest Money	2% of total quoted rate of tender amount in the name of PTA in shape of call deposit from scheduled bank of Pakistan.
7	Form of Earnest Money	Either a pay order or bank draft from scheduled bank in favour of PTA.
8	Earnest Money	Earnest Money of successful bidder will be retained as part of retention Money. Earnest money of un-successful bidder will be returned but not later than 30 days from the date of award of work to the successful bidder.
9	Retention Money	Retention Money is limited to 6% of the contract value.
10	Release of Retention Money	Retention Money will be released after 06 months after completion of work subject to no complaint against the work completed.
11	Time of commencement of work	Within 07 days of the issuance of Notice of Award
12	Time of completion of supply & work	30 days
13	Imposition of Penalty for non-completion of the work within stipulated time	0.5% of the contract price per day of project cost maximum up to the extent of 10 % of the project cost.
14	Insurance against injury to workmen	Safety of its employees from injury will be responsibility of the contractor.
15	In complete tender/bids will be rejected forthwith.	

16	Bid should be valid for at least 03 months from the date of submission.	
17	Pre-bid meeting	A pre bid meeting, if required, will be held before the submission of financial bid and date and time of this will be conveyed on the request of the bidder later.
18	The bidder will provide the copy of authorized dealer/partnership of the principal manufacturer, if required.	
19	Payment of the job will be made after successful supply and issuance of completion certificate from PTA.	
20	Tax will be deducted as per Government of Pakistan rules.	
21	Provision of NTN & GST No. (If applicable) along with copy.	
22	Bill should clearly indicate the NTN & GST No.(if applicable)	
23	An agreement will be made between the client and contractor on judicial paper of Rs. 100/-	
24	All material will be checked and approved by the Zonal Director Lahore before commissioning of work

3.	<p>Provision/Supply and fixing of new razor wire and Angle Y Type on wall up to the height of 7 ft. Complete in all respect.</p> <p><u>Razor Wire and Angle Y Type must conform to following specifications:-</u></p> <ul style="list-style-type: none"> a. Razor Wire gauge 10 mm and having Wire diameter 18 inches duly galvanized. b. 2"x 2"x 2/8" M/s Angle both arms of 1.5 feet and leg of 2 feet fixed in wall with rawal bolts of size 4" and having thickness 3/8". c. C/c distance b/w angles should not be more than 7 feet. d. Fixing of 2 x M/s bars of 2/8" between successive angles for support/holding razor wire All angles are to be painted with red oxide paint and then with black colour enamel make Berger/ICI 	500Rft

 - a) Tender Notice.
 - b) Bill of Quantity (BoQ)
 - c) General conditions of Contract/ Special Stipulations.
 - d) Addenda and Corrigenda, if any, issue by the clients and duly accepted by the contractor at the signing of the Contract.
 - e) Earnest money/ Tender Guarantee
 - f) Notice of award by the Client
 - g) Form of Agreement/ Contract Agreement
 - h) Clients order to commence the work.
 - i) Limit of Retention Money.
 - j) Any Correspondence by the Clients/Contractor mutually accepted by the Client and the Contractor.

3. In consideration of the payments to be made by the Client to the Contractor as given in BOQ, the contractor hereby covenants with the Clients to _____ the works in conformity in all respects with the provisions of the Contract.
4. The Clients hereby covenants to pay the Contractor in consideration of the renovation, completion and maintenance of Works, the contract Price at the times and in the manner prescribed by the Contract.
