BIDDING DOCUMENTS

Sealed bids are invited from well reputed and authorized dealers/suppliers/distributors registered with Sales Tax and Income Tax Department having at least five years of relevant business experience for supply of Four (4), Branded PC's with LED. Detailed specifications of above-mentioned PC's are provided in Annex-B of this document. Notice of the bids issued on PTA's/PPRA's websites is the part of this contract document.

Terms and Conditions

1. DATE AND TIME OF RECEIPT OF BIDS

- a. Bidding documents duly completed will be received on or before 01-04-2016 up to 10:30 AM, after the given time limit bidding documents will not be accepted.

The submission and evaluation of bids will be carried out under the "Single Stage Single Envelop Procedure". The bids will be opened at PTA Zonal Office Karachi on the same day at 11:00 AM, in presence of the bidder or bidder's representatives.

- b. Bids should be addressed to the Director (Enforcement) Pakistan Telecommunication Authority, Zonal Office, Wireless Compound, Opp. JPMC, Rafiqi Shaheed Road, Karachi.

3. **EARNEST MONEY**

- a. Earnest money in the shape of bankers cheque / demand draft in favor of Pakistan Telecommunication Authority, Islamabad amounting to 2% of the total bid amount **should only be attached with the Proposal** (Cheques / pay orders will not be accepted).
- b. **BID not accompanied with earnest money will be rejected without any right of appeal.**
- c. Earnest money of successful bidder will be retained till warranty period whereas earnest money of unsuccessful bidders will be returned after award of supply order to successful bidder.
- d. In case of cancelation of Supply Order due to default of the supplier, the earnest money shall be forfeited in favor of Pakistan Telecommunication Authority.

4. **PRICES**

- a. **The bidder should quote its rates clearly in Pak Rupees in the Proposal in both figures and words as per format attached at Annex-A**
- b. The rates quoted shall remain valid for three months from the date of opening of bids.
- c. Bid shall be in Pak rupees only and inclusive of all taxes i.e. GST etc.
- d. No transportation/carriage charges will be allowed.

5. **PAYMENT PROCEDURE**

- a. No advance payment shall be made against the supply of equipment / software mentioned in this bidding document. Payment of bill shall be made after delivery of the equipment /software at PTA Zonal Office, Opp. JPMC, Rafiqui Shaheed, Karachi and issuance of satisfactory completion/stock verification certificate by Zonal Purchase Committee.
- b. Payment shall be made after deduction of applicable taxes i.e. Income Tax etc. as per government rules.

6. **EQUIPMENT/ SOFTWARE**

- a. Items should be new, not used or refurbished. The components of the Computers / PC's should be assembled by the manufacturer.
- b. Items including its software should be arranged through the legal channels by providing all duties/taxes (if any) levied by the Govt. and towards this end.

7. **DELIVERY PERIOD**

- a. Delivery of items to be made within three (03) weeks after issuance of supply order.
- b. Vendor will be responsible for the safe supply of equipment / software at PTA Zonal Office, Karachi with the provision of at least one year free warranty / technical support mentioned at term 10.

8. **AUTHORIZED DEALER/DISTRIBUTOR/PARTNER**

Bidder shall be an authorized dealer/reseller/distributor/supplier/partner of the quoted brand/manufacturer OR the bidder can also be an authorized reseller of an authorized distributor/dealer/partner etc. Certificate of dealership or any other proof from the manufacturer is required in the name of the authorized dealer of the manufacturer.

9. **WARRANTY**

- a. Vendor will be responsible for the provision of free atleast onsite warranty / technical support with labour and parts for period of three years or manufacturer warranty whichever is greater.
- b. The warranty period will be considered from the date of actual date of delivery of IT equipment.

10. PENALTY

One (01) % of the total value of supply order will be charged as penalty (per week) on late supply of equipment upto a maximum of two (02) weeks. (Days less than six will be considered as one week). After expiry of two (02) weeks supply order will stand canceled and earnest money will be forfeited

11. INTEGRAL PART

- a. Annex-A is part of proposal which may be read/filled carefully, signed and stamped by the bidder and is to be submitted with the sealed envelope containing the proposal
- b. Annex-B is part of tender documents which may be read/filled carefully, signed and stamped by the bidder and are to be submitted.

12. DISQUALIFICATIONS

Offers are liable to be rejected if; there is any deviation from the instructions as laid down in the bid document i.e.

- a. Bid is submitted without the required earnest money.
- b. Offers are received after specified date and time.
- c. Specification and other requirements are not properly adhered to or different from those given in the bidding documents.
- d. Company registration, dealership, GST and NTN certificates are not attached.
- e. Service centre is not in Karachi.
- f. Supplier is not an authorized dealer/reseller/distributor/partner and warranty provider of the principal manufacturer for Pakistan as per section 9 of this document.
- g. Any inferior product / spec / requirement that mentioned at Annex-B.

14. **AFFIDAVIT**

Affidavit on **Legal Paper** to the effect that the firm has not been black listed by any government/semi government/autonomous body or company.
